



Petition for GMAT/GRE Waiver

The Global MBA—Triple Master program requires all applicants to supply an official GMAT or GRE score report. Under certain conditions, the GMAT or GRE may be waived for certain students.

Applicants who wish to be considered for a GMAT or GRE waiver must:

- Meet at least one of the classifications in the table below
- Complete a petition waiver form
- Supply the required documentation and submit to graduate admissions staff (incomplete waiver request forms will not be considered and will be returned)
- Have an application, official transcripts and resume submitted

Petition for GMAT/GRE waiver does not guarantee approval and is considered by the Admissions Committee in conjunction with an applicant’s complete admissions file. Applicants whose petition for a GMAT/GRE waiver is not approved are expected to take the exam.
