An I-20/DS-2019 will be created after the student has been admitted to the institution and an affidavit of financial support has been submitted.

Students may deduct their scholarship total from the total cost to equal the student balance owed to LOYNO. Each bank certification submitted must include the following: the sponsor's name (translated name must be printed on the original document); date (documents must be dated no more than 12 months prior to the date classes begin for the desired term of enrollment); amount of available funds and the type of currency.
